If the baffle at any time should ever fail (providing it was used accordingly to the instruction manual) we will replace it free of charge.

3 Ring Silencer Corp. certifies that all products manufactured by them are free of defects in materials or workmanship and they meet manufacturing specifications at the time of manufacture. It is our intent that the customer be completely satisfied with the product. All of our products are produced with the specific understanding that 3 Ring Silencer Corp. has taken every reasonable effort and precaution in providing our customers with inherently safe merchandise, and that we assume no liability whatsoever for unsafe handling or operation by the purchaser or his agents.

3 Ring Silencer Corp. assumes no responsibility whatsoever and we will not honor claims for damages, regardless of nature, for physical injury or property damage resulting from careless and/or irresponsible handling, adjustments to equipment, improper operation, neglect, or abuse. Use of ammunition that does not meet SAAMI specifications will void all warranties.

All silencers in this brochure are subject to local, state, and national laws including all NFA and BATF rules and regulations. All NFA items purchased are required to be transferred through a registered Federal Firearms License dealer who is Class III Special Operational Taxpayer. The purchaser of these goods is responsible for all NFA tax stamps and dealer transfer fees that may apply. A copy of both the FFL and SOT of the transferring party will be required on all orders containing NFA items.

### **Return and Refund Policy**

At no time should equipment be returned to 3 Ring Silencer Corporation without first obtaining authorization and an RMA Number. Our return policy is 30 days. If 30 days have passed since your purchase we unfortunately cannot offer you a refund or exchange. To be eligible for a return the product must be in new and unused condition and in the original packaging.

**Due to the NFA regulations surrounding firearm suppressors, all suppressor sales are final as long as the correct undamaged product was received by the customer.**

All suppressor accessories in new, unused condition may be eligible for return as long as it is within 30 days of the date of purchase. If 30 days have passed since your purchase we unfortunately cannot offer you a refund or exchange. Shipping costs are non-refundable and will be deducted from the amount of your refund if one is given. Please contact us at (215) 949-8374 for any return requests or questions on returns.

### Cancellation Policy

Suppressor backorders may be cancelled at any time prior to going into production without penalty if prior to our filing of BATFE transfer paperwork. Accessory backorders may be cancelled at any time prior to shipment without penalty. Once an order has been placed and BATFE paperwork has been filed there is fee schedule for returns & order cancellation based on administrative & production costs incurred by 3 Ring Silencer including allocation of inventory to a specific customer, preventing us from selling it to another customer during the time period that BATFE paperwork is being processed. In some cases, a VOID request or return transfer paperwork must also be filed so the silencer is not recorded as in your inventory by the BATFE adding to our administrative costs.

### Restock fees are as follows:

Order Canceled after BATFE paperwork is filed, but product has not yet shipped: 20% cancellation fee.

Order Canceled after BATFE forms are approved, but product has not yet shipped: 35% cancellation fee.

Order Canceled after shipment/receipt of product: 50% restocking fee.

Return of product after use or modification: Not Eligible for return and NO REFUNDS.

Blanket Orders are accepted for any combination of quantities of 100 or more. Blanket Orders expire 6 months from date of order and any remaining quantity on order at the time will be shipped accordingly and may not be cancelled. Any stock produced for a Blanket Order must be accepted by the customer and is not able to be cancelled.

### Modifications of Service and Prices
